### TERMS & CONDITIONS AND INSTRUCTIONS

- Selected tender superscribed "RE-TENDER FOR CONSUMABLES UNDER MULTI-DISCIPLINARY RESEARCH UNIT, FAAMCH, BARPETA" are invited from intending Suppliers/ Manufacturer/ Authorized Stockiest / Distributors or Authorized Dealers/Sub-Dealers to Principal-cum-Chief Superintendent, Fakhruddin Ali Ahmed Medical College & Hospital, Barpeta, Assam-781301 during the period from 2017 - 2018.
- 2. The bidder is expected to examine all terms and conditions in the bidding documents. Failure to furnish all information required by the bidding documents or submission of a bid not substantially responsive to the bidding documents in every respect will be at the bidder's risk and may result in the rejection of its bid.
- 3. The tender is to be submitted along with duly signed Terms & Conditions in a sealed cover which must be clearly marked with the "RE-TENDER FOR SUPPLY OF CONSUMABLE ITEMS FOR MULTI-DISCIPLINARY RESEARCH UNIT IN F.A.A. MEDICAL COLLEGE & HOSPITAL, BARPETA, ASSAM". The cover should be addressed to the "PRINCIPAL-CUM-CHIEF SUPERINTENDENT, FAAMCH, BARPETA, ASSAM-781301"
- 4. The bid should accompany all details regarding the terms offered by the bidder, compliance of terms and conditions, submission of attested Xerox copy of current and valid essential documents as Trade License, Copy of Pan Card, Document mentioning TIN number, Sales Tax Certificate/GST, Income Tax Certificate, Authorization of dealership in case of distributors/supplier. All the tender papers should be page numbered and the forwarding letter should include the list of documents submitted with the page number against the each documents.
- 5. The bid shall contain no interlineations, ensures or overwriting except as necessary to correct errors made by the bidder, in which case such corrections shall be initialized by the person or persons signing the bid.
- 6. Each tender is entitled to submit only one tender wherein he can, if necessary indicate alternative quotation. In case where more than one tender in a specified group is submitted by him well be liable to rejection.
- 7. The tender documents must be collected from the office on or before **last date of tender collection** & the bid must be received by the address specified not later than the time and date specified in the invitation for bids. In the event of the specified date for the submission of bids being declared a holiday for the purchaser, the bids will be received up to the appointed time on the next working day.
- 8. It is the responsibility of the bidders to see that the complete bidding documents, whether sent by post or by courier or by person are received by the time and date stipulated for receipt failing which the bid would be considered late and rejected.

- 9. Any bid received after the deadline for submission of bids prescribed will be rejected and/or returned unopened to the bidder.
- 10. The bidder may modify or withdraw its bid after the bid's submission provided that written notice of the modification or withdrawal is received by the purchaser prior to the deadline prescribed for submission or bids.
- 11. No bid may be modified subsequent to the deadline for submission of bids.
- 12. All items delivered should be subject to inspection on receipt and purchaser shall have full discretion to accept or reject.
- 13. The price charged for items supplied to the Institution or jobs shall in no event exceed the lowest at which the tenderers sells the store to any other person. If during contract period tenderer reduces the Sales Price, he should notify the same to the Principal-cum-Chief Superintendent, FAAMCH, Barpeta, Assam-781301.
- 14. If the firm fails to supply the items ordered within 40 days of signing of order, there will be liquidate damage equivalent to 5% of the delivered price of the delayed goods for each month or part of the month until actual delivery of performance upto a maximum of 10% of the delayed goods. The purchaser may consider termination of contract seeing its urgency even without extending the date of delivery.
- 15. The conditions of the renderer shall not be binding on this Institute.
- 16. The successful bidder shall deposit a security deposit of Rs. 10,000/-(Rupees ten thousand only) if the cost of item/items approved is more than 1lakh.
- 17. The institute reserves the right to forfeit security deposit of a firm, if the firm fails to execute the supply order.
- 18. All tenders from tenderer, must be accompanied by bid-security/earnest money of Rs.5000/- in the shape of MICR/NSC/Bank Drafts/STDR Order in favor of the Principal-cum-Chief Superintendent, FAAMCH, Barpeta, Assam-781301.Tender submitted without Earnest Money will be considered as non-responsive.

- 20. Quotation should be strictly according to specification & appropriate brochure/documents to the enclosed. Rates should be FOR basis. GST & other taxes where ever leviable should be directly showed along with price quoted separately.
- 21. Tender must accompany detail literature of the items quoted by the bidder.
- 22. Any firm, who is indulged in illegal bid rigging and cartelization in the recent past and have been penalized/debarred/blacklisted by any Government Agencies (Central/State/Undertaking) will not be considered in the tender.
